## ECREA TWG COMMUNICATION AND THE EUROPEAN PUBLIC SPHERE

# 1. Research:

A. In August 2015 – December 2016, the internal research project "The refugees crisis and the European Union" was undertaken and consisted of both quantitative and qualitative analysis of the way the "refugees crisis" has been reflected in the national and international public sphere.

The project was supervised by Prof. Alina Bârgăoanu and has three components:

1. Content analysis of mass- media, building on both the classical agenda-setting theory, and, also, on the third level agenda-setting (national and international/foreign);

2. Interviews and focus groups with students, elites, and members of the civil society at large;

3. Secondary analysis of Eurbarometers. The first results of this research project have been disseminated at the ECPR General Conference (Prague, Sept. 2016), where prof. Bargaoanu co-chaired the panel on Communication and the European public sphere. Furthermore, some of the key results of this research were included in the book co-edited by Alina Bârgăoanu – *Why Europe? Narratives and Counter-narratives of European Integration*, 2017, Peter Lang Publishing House - https://www.peterlang.com/view/product/26284?format=EPDF.

B. Doctoral research: prof. Bârgăoanu coordinates 13 PhD students who focus on European communication, Europeanization topics, and the European public sphere (please, see above). Doctoral research on EU communication and the European public sphere represents an essential key area of the Doctoral School at the National University of Political Studies and Public Administration, where prof. Bârgăoanu is based.
